## Temporary storage fees

### Storage related to combined transport

- Units arriving by train at the terminal have to be picked up as soon as possible.
- If the unit arrives by train and it cannot be picked up immediately, it could be stored at the terminal free of charge during the day of arrival and the following working day.
- For containers which are train related: 2 days free as from day of arrival. As from day 3 the following will be charged: 5.75 euro (excl. VAT)/TEU/day). On day 6 a onetime supplement of 24 euro will be invoiced.
- For swap bodies or trailers which are train related: 2 days free as from day of arrival. As from day 3 the following will be charged: 6.75 euro (excl. VAT)/ TEU/day). On day 6 an onetime supplement of 24 euro shall be invoiced.
- Dangerous goods units must in any event leave the Terminal within max. 30 days after arriving due to safety reasons. Terminal User has knowledge of, understood and agreed to the port regulations, to be consulted (at the date of signing) on <https://www.portofantwerpbruges.com/en/shipping/regulations-dangerous-goods>
- Storage is only counted for the days the terminal is opened
- Invoices will be issued monthly to the consignee. Payment is due within 30 days of the invoice date.

### Storage not related to combined transport

In urgent situations it is possible to drop units onto the terminal without that they leave with train (truck in – truck out).

- Container:
  - Storage: 5.75 euro (excl. VAT)/container TEU/day).
- Swap body (non-stackable unit):
  - Storage: 6.75 euro (excl. VAT)/swap body TEU/day).
- Trailer:
  - Administration fee: 26 euro (excl. VAT)/trailer).
  - Storage for trailer: 14.75 euro (excl. VAT)/trailer/day).

Storage for depot: no free days, storage costs from day of delivery until day of pick up.
